

# SBS Bank Kick for Cash – Terms and Conditions

---

*Southland Building Society is a registered bank and operates under the brand “SBS Bank” (referred to as SBS Bank, we or us). SBS Bank together with its subsidiaries is the **SBS Group**.*

SBS Bank is offering its members the chance to win four gold seated tickets to the Mitre10 Cup Southland Stags v Counties Manakau Steelers game on 28 August 2021 (the **Prize Draw**) and the opportunity to participate in the "Kick for Cash" competition at half-time to win up to \$1,000 (\$200 per successful kick) (the **Kick for Cash Competition**). Plus, we will donate \$500 to Ronald McDonald House South Island and \$500 to the winner's chosen charity.

## Entry

1. To enter the Prize Draw and participate in the Kick for Cash Competition, you must:
  - a. be a New Zealand resident;
  - b. be a new or existing member of SBS Bank; and
  - c. register your entry in the Prize Draw by completing the SBS Bank Kick for Cash form on our website at [sbsbank.co.nz/kick-for-cash](https://sbsbank.co.nz/kick-for-cash)

## Prize Draw Terms

2. The Prize Draw will run from Wednesday 11 August 2021 to Friday 20 August 2021 (the **Prize Draw Period**) and the prize draw winner will be randomly drawn at 11.00am on Monday 23 August 2021 (the **Prize Draw Date**).
3. Each entrant will be entitled to a maximum of one (1) entry into the Prize Draw. Only one opportunity to participate in the Kick for Cash Competition is available to be won. The prize is not redeemable for cash.
4. Entrants under 18 years of age must have parental or guardian approval to enter the Prize Draw and participate in the Competition. We may require a parent or guardian to confirm that they approve the minor's entry into the Prize Draw and Competition and that they have read and consented to these terms and conditions.
5. The Prize Draw is available for the Prize Draw Period only and may be withdrawn, amended or extended at any time by us at our discretion. We reserve the right to determine, in our sole discretion, to determine whether the prize winner has met the qualifying criteria outlined in clause 1 above. The prize winner may also be required to show us their identification and evidence of their ordinary residential address by producing an original, utility bill or such other relevant document.
6. The prize winner will be notified by their preferred contact method (email / telephone) and subsequently announced on the SBS Bank Facebook page once we have established that the prize winner has met the entry criteria for the Prize Draw. Where a prize winner is drawn but that person:
  - a. does not contact us within 3 working days; and/or
  - b. has not met (or is unable to produce evidence that he/she has met) the entry criteria for the Prize Draw and Competition in paragraph 1 and 4 (if applicable) above;we may, in our sole discretion, declare the entrant has forfeited their prize and the opportunity to participate in the Kick for Cash Competition and redraw as soon as practicable.

## Kick for Cash Competition Terms

7. At half-time at the Game, SBS Bank and/or Rugby Southland will set up the kicking station on the field and the prize winner will be invited on the field.
8. The prize winner will be placed in front of the goal post (the **kicking station**) and will be instructed by Rugby Southland to take their kick from the kicking station. The prize winner will have x5 attempts to kick the rugby ball over the goal post and can choose to take the kick from a tee, on the ground or from their hands. Any further attempts will be disqualified.
9. The prize winner will win \$200 for each successful kick over the goal post (the **Prize Money**). A maximum of \$1,000 of Prize Money can be won. If SBS Bank and/or Rugby Southland believe that the prize winner has made a successful kick, it will be deemed a successful kick.

10. The Prize Money will be deposited into the Prize winner's nominated SBS bank account the week following the Game.
11. The prize winner may nominate a proxy or replacement to participate in the Competition on their behalf (subject to SBS approval).

#### **General Terms**

12. Employees of the SBS Group and their immediate families are not eligible to enter into the Prize Draw or participate in the Competition. The prize winner hereby consents to any photography or other publicity we may reasonably request in conjunction with accepting the prize and/or participating in the Competition. The prize winner agrees that we may use their name and/or image for all reasonable publicity associated with the Prize Draw and the Competition. The prize winner agrees to make themselves available to SBS Bank for this purpose.

To the extent permitted by law, we shall not be held liable for any claims, damages, injuries, costs and expenses suffered, sustained or incurred (including but not limited to indirectly or consequentially) as a result of, arising out of, or any way connected with the Prize Draw or participation in the Competition.
14. All decisions of SBS Bank in relation to the Prize Draw and the Competition final and no correspondence will be entered into.
15. SBS Bank reserves the right to amend these terms and conditions at any time. Entry into the Prize draw and Competition is deemed as acceptance of these terms and conditions.
