

SBS Highlanders Ticket Giveaway – Terms and Conditions

Southland Building Society is a registered bank and operates under the brand "SBS Bank" (referred to as SBS Bank, we or us). SBS Bank together with its subsidiaries is the SBS Group.

SBS Bank is offering its Members the chance to win one of twelve family passes (each containing five tickets) to the Highlanders v Moana Pasifika game on 18 March 2022 (the **Prize Draw**).

Entry

- 1. To enter the Prize Draw, you must:
 - a. be a New Zealand resident;
 - b. be a new or existing member of SBS Bank; and
 - c. register your entry in the Prize Draw by clicking the "enter the draw" button in the email sent by SBS Bank to Members.

Prize Draw Terms

- The Prize Draw will run from Wednesday 9 March 2022 to 9am Tuesday 15 March 2022 (the Prize Draw Period) and the prize draw winners will be randomly drawn at 11.00am on Tuesday 15 March 2022 (the Prize Draw Date) and notified as soon as practicable by email.
- 3. Each entrant will be entitled to a maximum of one (1) entry into the Prize Draw. The prize is not redeemable for cash, cannot be swapped for a different game and seat selection is not available. All travel costs to attend the game and any other associated expenses, are to be met by prize winners.
- 4. Entrants under 18 years of age must have parental or guardian approval to enter the Prize Draw. We may require a parent or guardian to confirm that they approve the minor's entry into the Prize Draw and that they have read and consented to these terms and conditions.
- 5. The Prize Draw is available for the Prize Draw Period only and may be withdrawn, amended or extended at any time by us at our discretion. We reserve the right to determine, in our sole discretion, whether the prize winners have met the qualifying criteria outlined in clause 1 above. The prize winners may also be required to show us their identification and evidence of their ordinary residential address by producing an original utility bill or such other relevant document.
- 6. The prize winners will be notified by email and subsequently announced on the SBS Bank Facebook page once we have established that the prize winners have met the entry criteria for the Prize Draw. Where a prize winner is drawn but that person:
 - a. does not contact us within 3 working days; and/or
 - has not met (or is unable to produce evidence that he/she has met) the entry criteria for the Prize Draw in paragraph 1 and 4 (if applicable) above,

we may, in our sole discretion, declare the entrant has forfeited their prize and redraw as soon as practicable.

General Terms

Prize winners hereby consent to any photography or other publicity we may reasonably request in conjunction with accepting the prize. The prize winners agree that we may use their name and/or image for all reasonable publicity associated with the Prize Draw.
