- Terms and Conditions



*Southland Building Society is a registered bank and operates under the brand "SBS Bank" (referred to as **SBS Bank, we or us**). SBS Bank together with its subsidiaries is the **SBS Group**.*

SBS Southland Sharks Promotion

Open an i-save or SBS Lite account with us online and you will receive an SBS Bank backpack that has been signed by at least one of the Southland Sharks and a matching drink bottle (the **Promotion**). If you enter the Promotion, you will also automatically go into the draw (**Prize Draw**) to win return economy flights (Invercargill to Christchurch), overnight accommodation, and tickets for you and three others to the Southland Sharks away game against the Canterbury Rams at 7.30pm on July 2nd at Cowles Stadium, Christchurch (the **Prize**).

The Promotion commences at 9:00am on 21 May 2021 and closes at 11.59pm on 17 June 2021 (the **Promotional Period**). Entry into the Promotion and Prize Draw is deemed as acceptance of these terms and conditions.

Entry

- 1) To enter into the Promotion, you must:
 - i) be a New Zealand resident aged 18 years or over; and
 - ii) successfully open a new i-save or SBS Lite account during the Promotional Period via the "Southland Sharks Promotion" page located at: www.sbsbank.co.nz/southland-sharks-promotion.

Promotion Terms

- 2) Employees of the SBS Group and their immediate families are not eligible to enter the Promotion.
- 3) The Promotion is available for the Promotional Period only and may be withdrawn, amended or extended at any time by us at our discretion. We reserve the right, in our sole discretion, to determine whether any person has met the entry criteria for the Promotion set out in paragraph 1 above.
- 4) SBS Bank will contact you to advise when your SBS Bank backpack and matching drink bottle will be available for collection from the SBS Bank Invercargill Branch.

Prize Draw

- 5) The Prize Draw will be randomly drawn at 11.00am on Friday 18 June 2021. Each entrant in the Promotion will be entitled to a maximum of 1 (one) entry into the Prize Draw.
- 6) There will be one Prize to be won. The Prize is not redeemable for cash. Flights and accommodation included in the Prize will be subject to booking availability.
- 7) SBS Bank will not be liable for any amendments or alternations which are made to the Prize. If the prize winner wants to amend the Prize or request a prize package which differs in any way from the Prize (for example, requesting additional flights, extending dates, extra game tickets) any cost difference shall be met by the prize winner. Unless otherwise stated, the Prize does not include costs associated or incurred as a result of redeeming the Prize including, without limitation, transportation, meals and any other personal expenses or incidental costs.

- 8) The prize winner will be notified by telephone call once we have established that the prize winner has met the entry criteria for the Promotion. Where a prize winner is drawn, but that person:
- i) does not contact SBS Bank within five working days: and/or
 - ii) has not met (or is unable to produce evidence that he/she has met) the entry criteria for the Promotion in paragraph 1 above,
- we may, in our sole discretion, declare the entrant has forfeited their Prize and redraw as soon as practicable.
- 9) SBS Bank will use the prize winner's personal information which it already holds on its database for this Promotion. In particular, SBS Bank will use this personal information to notify the prize winner and to organize the Prize (which will include providing personal information to third party suppliers and organizers of the Prize for this purpose) and to verify the prize winner's identity.
