

## SBS Bank Mastercard Christmas Prize Draw Terms and Conditions

4. Cardholders whose account is any of the following are not eligible to participate in the competition:

  - c. cancelled; or
  - d. in breach of any terms and conditions herein and/or agreement during the competition period.
